Registration

If you haven't already secured your child's spot for A.P.A.C. Week, we encourage you to complete the registration process as soon as possible as space is limited to 25 campers. Our Friday to Saturday overnight campout location is **Irvine Ranch Outdoor Education Center**

The Irvine Ranch Outdoor Education Center is owned and operated by the <u>Orange County Council, Boy</u> Scouts of America.

Camp fees cover all activities for the week including meals for the overnighter.

New campers will not be admitted without signed forms! Returning campers who have not attended the Club this past school year are required to submit new forms.

In addition to Boys & Girls Club of Laguna Beach emergency forms, overnight campers are required to fill out site specific health forms <u>ON THIS LINK</u>. These forms are also required to participate in any shooting sport, climbing, challenge course, zip line, or aquatic activity. Trained IROEC program team members direct the programs in these locations and certified lifeguards oversee all aquatic activities.

During these events the public has the unqualified right to take pictures and/or recordings of your child and grant the perpetual right to use your child's likeness, image, photo (collectively, "image"), without compensation, for broadcast or exhibition in any medium and to put the finished pictures/recordings to any legitimate use without limitation or reservation. You, the parent, or legal guardian does hereby waive, release and forever discharge The Boys & Girls Club of Laguna Beach from and against any and all claims or actions arising out of or resulting from any use of your child's image. The public shall not be obligated to use, and may elect not to use, your child's image.

SUNSCREEN UTILIZATION PERMISSION

As the parent of the child, I give permission for staff to apply sunscreen of SPF 15 or higher to my child when he or she is engaging in outdoor activities. I understand that sunscreen may be applied to exposed skin, including but not limited to the face, tops of ears, nose, bare shoulders, arms, and legs.

I acknowledge that application alone will not prevent my child from sunburn and release from liability the staff of the Boys & Girls Club of Laguna Beach if sunburn is to occur.

I (we) the parent, parents or legal guardian of the child listed on this field trip/event permission slip, a minor, do hereby request that he/she should the need arise, do hereby authorize and consent to any x-ray examination, anesthetic, medical or surgical diagnosis rendered under the general or special supervision of any member of the medical staff and emergency room staff licensed under the provisions of the Medicine Practice Act or dentist licensed under the provisions of the Dental Practice Act and on the staff of any acute general hospital holding a current license to operate a hospital from the state of California, Department of Health. It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required. This authorization is given to provide authority and power to render care which the physician, in the exercise of his/her best judgment may deem advisable. It is understood that effort shall be made to contact the legal guardian prior to rendering treatment to the patient, but that any of the above treatment will not be withheld if the guardian cannot be reached. I will not hold Boys & Girls Clubs of Laguna Beach liable for medical aid rendered.

This authorization is given pursuant to Section 25.8 of the Civil Code of California and remains effective only for the date of this field trip/event.
