Returning campers who have not attended the Club this past school year are required to submit new forms.

These forms are also required to participate in any shooting sport, climbing, challenge course, zip line, or aquatic activity. Trained IROEC program team members direct the programs in these locations and certified lifeguards oversee all aquatic activities.

You, the parent, or legal guardian does hereby waive, release and forever discharge The Boys & Girls Club of Laguna Beach from and against any and all claims or actions arising out of or resulting from any use of your child's image. The public shall not be obligated to use, and may elect not to use, your child's image.

It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required. This authorization is given to provide authority and power to render care which the physician, in the exercise of his/her best judgment may deem advisable. It is understood that effort shall be made to contact the legal guardian prior to rendering treatment to the patient, but that any of the above treatment will not be withheld if the guardian cannot be reached.
